Through this program, we also provide community-strengthening trainings for our partners three times a year, so that they are equipped with the knowledge and information needed to create safe spaces for girls. These trainings offer guidance on menstrual health management and sexual and reproductive health and rights, while sharing best practices to implement child protection policies through a human rights lens. Through our Health Education programming, ZanaAfrica Foundation also creates scalable health and rights education resources for adolescent and teen girls based in UNESCOs guidelines on adolescent health education and through questions collected from over 1,000 girls.
