ZanaAfrica Mission & Program / Intervention description

ZanaAfrica equips adolescent girls with the tools they need to safely navigate puberty and unlock their potential. Working in Kenya, ZanaAfrica expands access to a proven intervention of rights-based reproductive health education paired with sanitary pads to marginalized girls. We uniquely recognize that this powerful combination is one of the smallest hinges to unlock girls' potential and break cycles of poverty.

In partnership with the Bill & Melinda Gates Foundation, Plan International, and the Population Council, ZanaAfrica conducted an evaluation of its program model among 3,500 girls across 140 schools from 2017-2019. This pioneering study proved that ZanaAfrica's intervention of rights-based reproductive health and life skills education delivered with sanitary pads leads to improvements in reproductive health knowledge, improved self-confidence and agency, as well as shifts to more equitable gender norms among girls.

Each of these outcomes independently, and combined, help girls to have more control over their bodies, their decisions, and their futures. These outcomes are very difficult ones to achieve, and our interventions did so in the relatively short timeframe of 18 months. With a proven solution to address the challenges facing girls across Kenya, ZanaAfrica is scaling its program nationally in partnership with Government and community organizations, with a goal to reach over 200,000+ beneficiaries by 2023.
